The GAP fee is a flat rate regardless of the number of hours used and includes morning and afternoon services. Payment for this service is non-refundable and non-transferable.

Payments

- Eleven installments beginning July 2024 and ending May 2025.
- Ten installments beginning August 2024 and ending May 2025.
- **All GAP payments are to be paid through your FACTS account or in full by August 1.**
Families who are two weeks behind in their financial obligations for GAP will not be allowed to participate until their account is current. Report cards will be held if a balance remains on an account.

Morning GAP - \$25/week (per family)

- If you are not enrolled in full-time or part-time GAP, early morning care is available from 6:30–7:00 am.
- After 7:00 am, child care services are provided by the school at no charge to parents.

Occasional Use - \$25/day (per student)

- May be **requested** in the event of an emergency, job-related temporary schedule change, short-term medical, or parent-teacher conferences.
- To request occasional service, an email or written request must be submitted to the GAP director at brandi.iskander@cathedralemail.com at least **one week prior** to need. In the case of a sudden emergency, a call may be made to the school office for verbal approval.
- Students who use occasional use **more than 3 times in one quarter** will be automatically enrolled in part-time or full-time GAP.

Penalty Fees - \$25/occasion (per student)

- Applies to **part-time** students not picked up by 4:30 pm. Students who are picked up late **more than 3 times in one quarter** will be automatically enrolled in full-time GAP.
- Applies every 15 minutes to **full time** students not picked up by 6:00 pm. Students who are picked up late **more than 3 times in one quarter** will be automatically withdrawn from GAP services.

This form must be returned to the school office by June 15th. Please complete one form per student.

By enrolling my child in the GAP program, I understand the fee schedule and that the fees will be paid through my FACTS account. I also understand the penalty fee for leaving my child beyond the time I have chosen.
